We cannot review or consider applications received after this date. Any credentials brought on show-site will not be accepted. Applicants will be notified of application decision by May 23, 2022. Please note: Any and all expenses for attending the show are the responsibility of the applicant.

**Acceptable Credentials:** • Business card or press badge from legitimate press outlet/ publication • Letter verifying freelance writer's assignment from authorized media publication. **PLEASE NOTE:** Premiere Orlando are owned and operated by Premiere Show Group. Press passes to other industry events will not be accepted as credentials.
